

Supa Quick – Wheel Well Competition

Terms and Conditions

Please read these Competition rules carefully. These Competition rules (“rules”) explain your rights and duties in connection with this Competition. If you take part in this Competition or accept any prize, these rules will apply to you and you agree that the Promoter can assume that you have read and have agreed to be legally bound to these Competition rules.

1. Introduction

Supa Quick is running a Wheel Well competition. The first 100 participants to donate a kids car seat at any Supa Quick store and submit a picture of themselves doing so between 4 October and 30 October 2021 and will receive a wireless Power Bank. In addition one person who donates a car seat between 1 October and 30 October 2021 will be randomly drawn to win a set of four Bridgestone passenger tyres for the winner’s vehicle. Any of the below car seats will qualify:

- Infant Car Seat
- Toddler car seat
- Booster seat

2. Definitions

2.1 “Participant” means the person who donated a car seat at Supa Quick.

2.2 Promoter” means Bridgestone Retail (Pty) Ltd (Supa Quick) or its agencies used to promote this Competition.

3.1 100x Wireless Power Banks (for the first one hundred entrants)

3.2 A set of 4x Bridgestone passenger tyres for the winner’s vehicle (Random draw).

4. Whom May enter

4.1 All Participants, at the time of entering the competition:

4.2 Be a natural person and be at least 18 (eighteen) years of age;

The first one hundred participants that complete their entry will win a Wireless Power Bank.

6.3 In addition once the competition has concluded, one winner will be randomly chosen from all entries received to win a set of any 4x Bridgestone tyres that fit the winner's vehicle.
